

TERMS OF SERVICE

SECTION 1. GENERAL PROVISIONS

1.1. These Terms of Service (hereinafter referred to as the "Terms", "Terms of Service") is an agreement concluded between the Website Owner (hereinafter referred to as "CrypStock", "Company", "we", "us") and the User (hereinafter referred to as "User", "You") of the website <http://crypstock.io> (hereinafter the "Website").

1.2. By using the Website, you indicate that you accept these Terms of Service in full and that you agree to abide by them. Your access to and use of the Website and CrypStock's Services are conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Website. If you do not agree to these Terms of Service, please refrain from using this Website.

1.3. These Terms of Service, Terms of Token Sale, and Privacy Policy make a single set of rules which regulates the relationships between Purchaser and CrypStock. You cannot accept it partially, this set of rules should be accepted in full. Should any conflict between these Terms of Service and Terms of Token Sale happens, Terms of Token Sale shall prevail. Should any conflict between Terms of Service and Privacy Policy happens, Terms of Service shall prevail.

1.4. Please read these Terms carefully. Note that each User must comply with this Terms.

1.5. You confirm that You are of an age of maturity to enter into these Terms, meet all other eligibility requirements, are legally entitled to use the Internet and services like those provided by CrypStock and have not had your right to use our service previously suspended or revoked by us. If you are registering as a business entity, you personally guarantee that you have the authority to bind the entity to these Terms.

1.6. You shall not use the Website if you are prohibited under the applicable law from using it. Any User that is in any manner limited or prohibited from the purchase, possession, transfer, use or other transaction involving any amount of ICS Tokens under the applicable law should not access this Website and is prohibited accessing, referencing, engaging, or otherwise using this Website.

SECTION 2. REGISTRATION AND ACCOUNT

2.1. In order to use the CrypStock's Services you are required to create an account with us on the Website. You will be able to purchase ICS tokens only once when you create an account on the Website.

2.2. In order to register an account you are required to provide us with your personal information such as name, address, e-mail address, contact number and password.

2.3. CrypStock may require you to provide additional information to verify Your identity, address, source of funds or any other information in your account, such as your date of birth, copy of ID, citizenship, country of residence, and other information.

2.4. The account may not be activated unless You provide the following details and digitized copies (not PDF) of the documents:

a) Name;

b) Date of birth (for individuals) or date of registration (for corporations);

c) Address (residence and mailing addresses (if different) for a natural person; or principal place of business and/or registered address (if different) for a person other than a natural person);

d) Identification number (a taxpayer identification number, passport number and country of issuance, alien identification card number, or number and country of issuance of any other government-issued document evidencing nationality or residence and bearing a photograph or similar safeguard).

e) As an evidence of your nationality or residence you shall provide the Company with a copy of your passport in high quality color format. If You represent a legal entity, you shall provide the Company with documents showing the legal existence of such legal entity, such as certificate of incorporation/registration and other similar document certifying the registration of legal entity in its country of residence.

2.5. We may, at our discretion, send to the User intimation of reasons for non-activation of the account. We are not under an obligation to however notify rejection of activation of new accounts.

2.6. You represent and warrant that all required registration information you submit is complete, current and accurate, and you will maintain the accuracy of such information. CrypStock is not obligated to verify your identity or any other personal information and may do it at its own discretion. You are responsible for maintaining the confidentiality of your account login information and are fully responsible for all activities that occur under your account. You agree to immediately notify us of any unauthorized use, or suspected unauthorized use of your account or any other breach of security. The Website cannot and will not be liable for any loss or damage arising from your failure to comply with the above requirements. You must not share your password or other

access credentials with any other person or entity that is not authorized to access your account. Without limiting the foregoing, you are solely responsible for any activities or actions that occur under your account access credentials. We encourage you to use a “strong” password (a password that includes a combination of upper and lower-case letters, numbers, and symbols) with your account. We cannot and will not be liable for any loss or damage arising from your failure to comply with any of the above.

2.7. You shall be fully responsible for all activities that occur under your account, irrespective of personal knowledge of the same or otherwise;

2.8. You agree to provide and maintain accurate, current and complete information about your account. Without limiting the foregoing, in the event you change any of your personal information as mentioned above in these Terms, you will update your account information promptly.

2.9. We reserve the right to suspend or terminate your account if any information provided during the registration process or thereafter proves to be inaccurate, false or misleading.

2.10. If you have reason to believe that your account is no longer secure, then you must immediately notify us at info@cryptstock.io.

2.11. You may not transfer or sell your account to a third party. You agree that you exclusively will access and use your account, and may not transfer the right of its use or disclose any log-in credentials to a third party without CrypStock’s written consent. You agree to take full responsibility for any activity that occurs through the use of your account, and cannot transfer this obligation to any third party.

2.12. CrypStock reserves the right to refuse service to anyone, for any reason, at any time.

2.13. One individual can own only one account.

2.14. You agree to comply with all local laws regarding online conduct and acceptable content.

SECTION 3. USER INFORMATION

3.1. CrypStock shall take reasonable care and caution in the collection and retention of the User’s information, data and documents provided. We shall comply with the Privacy Policy available at the Website, for collection and retention of User’s data, including sensitive information of the User.

SECTION 4. ILLEGAL AND PROHIBITED USE

4.1. You will use your account only for legal purposes and shall not use any part of our Services, for or in connection with or to perpetuate or commit any actions, which amount to a violation of any law, statute, ordinance or regulation. You shall be solely liable for any such illegal activities that you undertake and the consequences arising therefrom including those initiated by us, as more fully set out hereunder.

4.2. You represent and warrants that you are not using any proceeds of criminal or illegal activity, and that no transaction involving ICS Tokens are being used to facilitate any criminal or illegal activity. You confirm that you do not intend to hinder, delay or defraud CrypStock or any other CrypStock's users or engage in any illegal conduct and or unlawful activity in relation to money laundering, drug/human/weapon trafficking, terrorist activities or tax evasion. You represent and warrant that you will not use the Website or CrypStock's Services for any criminal, illegal, or otherwise prohibited purposes.

4.3. You must not misuse the Website by knowingly introducing viruses, trojans, worms, logic bombs or other material which is malicious or technologically harmful. You must not attempt to gain unauthorized access to the Website, the server on which the Website is stored or any server, computer or database connected to this Website. You must not attack the Website via a denial-of-service attack.

4.4. You represent and warrant that you will not in any way use the Website or CrypStock's Services to distribute spam, junk communications or chain letters.

SECTION 5. SECURITY

5.1. You are responsible for implementing reasonable measures for securing CrypStock account you use to purchase ICS Tokens, including any requisite private key(s) or passwords or other credentials necessary to access such storage mechanism(s). If your private key(s) or passwords or other access credentials are lost, you may lose access to your ICS Tokens. We are not responsible for any such losses

5.2. CrypStock's services are offered only on the digital domain, which is subject to risks including offensive attacks. We shall not be liable for any loss, harm or damage caused to the User's account arises due to events including commissions or omissions by third parties, forces of nature, offensive attacks on our servers or on the personal devices of the users or any loss caused by conditions or events beyond our reasonable control.

5.3. The above limitation on liability includes any event set out hereunder including acts of god; fire, act of terrorists, act of civil or military authorities, civil disturbance, war, alien or zombie attack, strike or other labor dispute,

interruption in telecommunications or Internet services or network provider services, failure of equipment and/or software, other catastrophe or any other occurrence which is beyond our reasonable control.

5.4. We shall not be liable for any harm, loss or damage caused to User due to a data breach of confidential information of the User, including of the User account details or User password, including when such breach has occurred due to the User sharing the details with third parties or the User's failure to follow due diligence. We shall also not be responsible for disclosure by User of account details including by falling prey by way of a phishing attack.

SECTION 6. CRYPSTOCK DOES NOT PROVIDE LEGAL, FINANCIAL OR OTHER PROFESSIONAL ADVICE

6.1. In no way information contained in the Website shall be considered as legal, financial or any other kind of specialized or expert advice on which the User might rely. You agree to pay for any legal fees or other costs that incurred by CrypStock or any other indemnified parties as a result of your actions.

11.1 CrypStock does not guarantee any level of performance or the continued, uninterrupted availability of CrypStock's Services. We do not guarantee the accuracy of any information provided on the Website. We hereby disclaims all warranties and conditions with regard to the Website, information, software, products, services and related graphics, including all implied warranties or conditions of merchantability, fitness for a particular purpose, that not expressly made in these Terms.

SECTION 12. AMENDMENTS

12.1. These Terms may be modified by CrypStock at any time for any reason by placing modified Terms on the Website. We will provide notice of any amendment to these Terms by posting any revised terms to the Website and updating the "Last updated" field above accordingly or by any other method we deem appropriate. We are not obligated to provide notice in any other method beyond these. Any change to these Terms will be effective immediately upon such notice.

SECTION 13. INTERNATIONAL USE

13.1. We do not represent or warrant that the Website or any part thereof, is appropriate or available for use in any particular jurisdiction. Those who choose to access the Website do so on their own initiative and at their own risk, and are responsible for complying with all local laws, rules and regulations, including laws regulating the export of data.
